Mr Tokunbo's effort in respect of the book consisted, in the most part, of the drawing of various vertical and horizontal lines, and nothing more. In December, 2021, Mr Tokunbo discovered that Alujibiti Coy Ltd, a printing outfit, was mass producing and selling "Standard Scheme of Work and Record Book", a book of exactly the same kind as his own. Upon investigation, Mr Tokunbo discovered that one Mr Mumu, a former teacher at Irawo Grammar School, gave Alujibiti Coy Ltd a sample of Mr Tokunbo's book.

Mr Tokunbo intends to sue Alujibiti Coy Ltd.

Advise Mr Tokunbo.

- (b) Do a brief discussion of the type of individuals and corporate entities whose works are eligible for protection under Nigeria's Copyright Act
- 2. "Protection of copyright is the best means of promoting creativity, stimulating men and women of talent to create further works, and thus; building up the national heritage. Lack of protection kills talent and even national prestige"-Abdul Hassan, Copyright and Development (1982) Vol 26, No 1 and 2, Copyright Bulletin, p.11

Against the background of the above statement, analyse the provisions made by Nigeria's Copyright Act to protect copyright owners in Nigeria.

3. Taco Inc, Jim Roy Coy Ltd, Cool K Inc, and Harrison Ford & Sons were companies registered in France, USA, UK and Australia respectively. All these firms were musical recording companies. The 4 companies jointly entered into an agreement with Ibukun Orisun Iye Records and Mavin Records, which were musical recording companies registered in Nigeria. The 6 companies jointly recorded, in Nigeria, a musical piece, "My Heart Is On Fire For You", done by Toto, a celebrated hip-hop artist of Ghanaian origin. A month after the recording and during which the musical piece had topped the charts, both in Nigeria and overseas, another musical recording company, SugarPussy, registered in Nigeria, started mass producing and selling copies of Toto's musical piece "My Heart Is On Fire For You", to the annoyance of the 6 recording companies that jointly recorded the song.

All the 6 recording companies intend to sue SugarPussy, for infringing on their copyright.

Advise the 6 companies.
